To ensure higher staffing ratio for PE activities where this is required.	The PE pupil premium has funded the cost of staffing the school hydro pool. This money has paid for an assistant to be on the poolside; this helps the pool stay open during the school week and provides primary aged pupils with multiple swimming opportunities.  We currently have 5 Staff trained in the First Aid at Work qualification. This is a minimal qualification the local authority has identified all poolside spotters must have.	56% £9262	All primary aged pupils have access to the school hydro pool; this has been made easier by the school having a full-time swimming assistant who ensures the pool remains open. Pupils have access to swimming sessions which allows for sequential learning.	To maintain this provision in future years we would have used separate funding from Active Devon to train up a member of staff to be able to train staff to have the First Aid at Work Qualification. This will provide more possible spotters for sessions.

The school has hired (until July 2025) Sidmouth swimming pool every Monday and Tuesday afternoon (together with a swimming coach) for a session for selected Key Stage 2 pupils (those whose swimming skills are beyond those of the school hydro pool).	29.6% £4896	For pupils in Key Stage 2 their confidence in and around the pool has improved. Pupils will move to and from the pool with greater independence and are able to follow instructions from swimming teachers to develop their buoyancy and swimming strokes. This has allowed for many Key Stage 2 pupils to access sport and PE in their community and participate against similar pupils from other schools. Recently Key Stage 2 pupils accessed a Cricket event at Budleigh Salterton Cricket Club (May, 2025)	0%	Participation in these activities has improved the pupils' self-confidence. Pupils have demonstrated greater motivation during PE lessons as they know they will have the opportunity to participate in a different setting, possibly as part of a competition.
