Attendance

If you are thinking about requesting time off for your child during the summer term, please be aware that I manage and respond to each request on an individual basis. In reaching my decision as to whether a term time absence request should be authorised, I have to work within the guidelines laid down by Ofsted and the Local Authority, as well as taking your family circumstances into account. Because Ofsted consider maximising attendance to be part of the school's safeguarding role and make judgements about us based on this, I have to respond to you in a formal manner. This means that the letter you receive includes a statement about the importance of good attendance, even if your child's attendance is very good. By including a formal statement, we are able to demonstrate to Ofsted that we take this aspect of our safeguarding role seriously. Please be assured that I will always reach my decision based on an assessment of your individual needs as a family.

In response to the questionnaire and in conjunction with our Parent Working party, a new home / school book is being produced for this term and will be coming home next week.

Online Safety

Live streaming is becoming one of the most popular online activities for children and young people. Apps such as Musical.ly, Live.me, Periscope and YouNow are all soaring in popularity. In response to this, other well established apps such as Facebook have added live streaming functions. I know that some of our pupils are already using apps such as Musical.ly and like to talk about them in school. With this in mind, it's important that parents and carers, as well as school, are able to stay up to date with how children can stay safe when using these types of platforms.

We all need to be aware of the specific risks children and young people face whilst live streaming, such as the immediacy of 'live contact' and the large numbers of users communicating with a young person at any one time, and the affirmation gained via views and gifts. Where appropriate, we will be working with our pupils in school to make sure they are aware of the type of tactics offenders use on live streaming platforms and know how to respond safely to possible pressure and manipulation from adult offenders. We will be using resources made available by CEOP (The Child Exploitation and Online Protection).
